Allebach moved to approve the following consent agenda items

- A. Approve the minutes of the Regular Meeting held on April 15, 2020.
- B. Approve the Financial Report and Treasurer's Report dated April 30, 2020.
- C. Approve the Purchase Order List from April 14, 2020 through May 18, 2020 in the amount of \$44,202.05.

- D. Approve the checklist from April 16, 2020 through May 20, 2020 in the amount of \$294,572.41.
- E. Approve the High School Financial Account Reports (Activities Account, Athletic Fund, and Letterman's Club) dated April 30, 2020.

Exposito moved to adopt the proposed budget as presented for the 2020-2021 fiscal year, be advertised, and put on display in the office of the Superintendent for the required thirty days as per section 687 PA School Code, as amended, that the proposed and/or amended budget be formally adopted on June 24, 2020 and that the millage for the Union Area School District be set at 14.92 (no increase) for the 2020-2021 fiscal year. The proposed budget is \$12,705,095. Sylvester seconded (9 yes). The motion carried.

Friend moved to approve the 2020-21 homestead/farmstead resolution (Property Tax Reduction), as presented. Exposito seconded (9 yes). The motion carried.

Allebach moved to reenact without substantial change, the following resolutions imposing the following taxes for the 2019-20 fiscal year:

- A. A Per Capita Tax of \$5 per person on all residents of the district over 18 years of age under the authority of Section 679, PA School Code, as amended.
- B. A tax of 1% on wage and net profits earned by every resident of the district under the authority of Act 511.
- C. A Per Capita Tax of \$5 per person on every resident of the district over 18 years of age under the authority of Act 511.
- D. A \$5 annual Occupational Privilege Tax to be imposed and levied on each individual engaged in occupation within the corporate limits of the Union Area School District, under the authority of Act 511.
- E. A tax of 1% on all transfers of real estate under the authority of Act 511.

Mrozek seconded (9 yes). The motion carried.

Friend moved to approve the attached resolution for the 2020-2021 real estate taxes. The resolution reflects a thirty (30) day extension to discount, face, and penalty for one year only, expiring June 30, 2021 due to circumstances relating to COVID-19. Sylvester seconded (9 yes). The motion carried.

Allebach moved to name First Commonwealth Bank of PA, Union Township Office as a depository for the funds of the Cafeteria, High School, Athletics, and Letterman's account for the 2020-21 school year. Exposito seconded (9 yes). The motion carried.

Allebach moved to approve First Commonwealth Bank of PA, Union Township Office as a depository and Treasurer for the General Fund and Payroll Accounts for Union Area School District for the 2020-21 fiscal year. Pacella seconded (9 yes). The motion carried.

Exposito moved to approve Attorney Louis Perrotta to serve as the Union Area School Board Solicitor for the 2020-21 fiscal year at a rate of \$115.00 per hour and no retainer (no increase). Allebach seconded (9 yes). The moion carried.

Mr. Perrotta thanks the Board and the approval to continue his services.

Allebach moved to accept the donations made by the UAAA from July 2019 through May 2020 in the amount of \$9,611.56. Sylvester seconded (9 yes). The motion carried.
