Allebach moved to hire Ms. Bethany Butler as a Part-Time Elementary Art Teacher at Step 1, with no health care benefits and in accordance with the UAEA Agreement, effective December 2, 2020 and pending receipt of all proper paperwork. Biondi seconded (8 yes). The motion carried.
